FLORIDA TO REGULATE ATLANTIC RED SNAPPER FISHERY

On November 10, 2025 the Florida Fish and Wildlife Conservation Commission (FWC) formally submitted an Exempted Fishing Permit (EFP) to U.S. Commerce Secretary Howard Lutnick that, upon approval, will allow Florida to assume management of the recreational red snapper fishery in state and federal waters off the Atlantic Coast beginning in 2026. The state of Florida has managed and expanded the Gulf snapper seasons while successfully insuring a growing fishery.

As submitted to the National Oceanic and Atmospheric Administration (NOAA), Florida would implement a 39-day Atlantic Red Snapper season, a dramatic expansion from the two-day federal season allowed in 2025, an 1850% increase in fishing. The proposed season includes:

- Summer: From May 22 (Memorial Day Weekend) through June 20
- Fall: Three-day weekends in October (Oct. 2-4, 9-11, and 16-18)

Florida's application leverages the same process used in the Gulf, where state management has produced results that support the species and anglers. Since assuming management in the Gulf, the Red Snapper season has risen from 3 to 127 days, an over 4100% increase for Florida's Gulf anglers and for-hire operators.

Anyone fishing for red snapper from a private recreational vessel—in state or federal waters—must be registered as a State Reef Fish Angler (with annual renewal), even if exempt from fishing license requirements. Registration is available at GoOutdoorsFlorida.com.

JOINT U.S.-BAHAMAS PROPOSAL ON VISITING YACHT FEES

The Association of Bahamas Marinas (ABM) and the Florida Council of Yacht Clubs (FCYC) have jointly advanced a proposal calling for reciprocal or reduced entry and cruising fees for visiting yachts traveling between the United States and the Commonwealth of The Bahamas.

Bahamas boating regulations changed significantly in mid-2025 with new, higher cruising permit fees (e.g., \$500 for under 50ft, \$1,000 for 50-100ft), separate fishing permits, and mandatory Automatic Identification System (AIS) for vessels over 50 feet, plus a new digital cruising card option for frequent visitors, all impacting costs and entry, with some boaters feeling the increased fees and rules are less welcoming.

Together, ABM and FCYC represent a broad network of marinas and yacht clubs that form the foundation of boating activity in both regions. The proposal initially focuses on yacht club members as a well-defined and verifiable group of responsible boaters, while serving as a potential framework for broader marine-tourism initiatives in the future. A key objective is to increase visitation and length of stay at Bahamian-owned marinas, helping ensure that the economic benefits of marine tourism flow directly into local Bahamian communities.

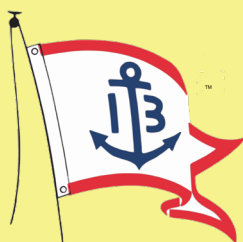

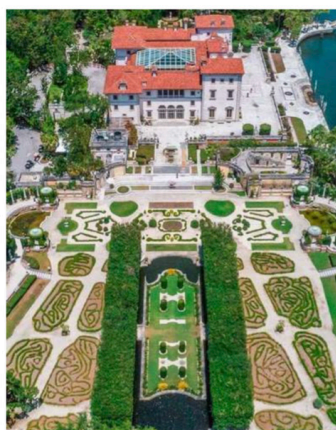

The **Vizcaya Museum and Gardens** is a historic estate in Coconut Grove, Miami, formerly the villa of businessman James Deering. Built in the early 20th century, it features Italian Renaissance-inspired gardens and Mediterranean Revival architecture with Baroque elements. Key figures in its design include architect F. Burrall Hoffman, design director Paul Chalfin, associate architect Iwahiko Tsumanuma, and landscape architect Diego Suarez. MEMBER CLUB INFO AND UPDATES



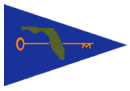

Bird Key Yacht Club presented an excellent *best practices* concept on a speaker series program. Dr. Kelly McAdams, VP of Conservation Education at the Clearwater Marine Aquarium, gave an outstanding presentation on conservation and resource management.



Commodore Joan Carter and her excellent staff did a splendid job in hosting our FCYC meeting. As a small club not having hosted a FCYC meeting previously they managed beautifully. It is friendly, hospitable club worth visiting.

FLORIDA LEGISLATION

One of the FCYC key mission issues is the monitoring of legislation that affects boating, navigation and club management. When the Executive Committee believes impending legislation may affect member clubs we engage our attorneys in Tallahassee to respond to the potential risk.

FCYC is represented at the Capitol by Johnson & Blanton, advocating on behalf of the Council for 15 years. With the 2026 Legislative Session starting January 13th, several bills have surfaced so far and could impact boaters:

- Boating Safety (SB 900 – Senator Garcia): Strengthens safety rules, clarifies boater ID and education requirements, and increases penalties for reckless operation or boating under the influence. Most responsible boaters will see little day-to-day change, but unsafe behavior carries serious consequences.
- Nonprofit Corporations (SB 554 – Senator Bernard): Updates governance rules, director duties,

filings, and member access to records. Provides greater flexibility for organizational changes. Effective July 1, 2026.

- Firearms on Vessels (SB 80 – Senator Berman; HB 159 – Rep. Hinson; SB 256 – Senator Rouson): Requires secure storage of firearms on vessels whenever unattended, promoting safety and legal clarity without affecting recreational boating.
- Public Waters (HB 669 – Rep. Gossett-Seidman): Focuses on health advisories and water access. Boaters should watch for posted signs, water quality notices, and potential temporary closures.

FLEET CAPTAIN'S UPDATES



The West Coast Fleet Captains held their inaugural information meeting at the Isles Yacht Club on October 24th. Hosted by Terry Wright, the agenda included the presentation "National Electrical Code & Stray Currents in Marinas" by Master Electrician, Robert Elie. This was a very informative meeting and the presentation was excellent. The next meeting of the West Coast Fleet Captains will be held at the Venice Yacht Club on December 19th.

U. S. Coast Guard West Report:

- All mariners are advised to transit the area between pass-a-grille channel dbn 3 to dbn 7 with caution due to extreme shoaling. gadsden point cut range front light (llnr 22850) is rptd very dim. All mariners transit the area with caution. Tampa Bay cut C channel inbound rrl (llnr 22605) is rptd extinguished. All mariners transit the area with caution.
- Big Bayou point channel dbn 5 (llnr 26454.2) is reported broken. Exercise caution while transiting the area.

- Gordon Pass channel buoy 1 (llnr 17453) and Gordon Pass channel light 3 (llnr 17460) have been temporarily disestablished and will be re-established at the conclusion of dredging operations. Transit with caution.
- Mullet Key range front light (llnr 22355) is leaning over into water 45 degrees west and has been set with a white trlb 18 yards from structure channelward. Transit the area with caution.
- Mullet Key channel light buoy 20 (llnr 22350) is reported extinguished. Transit the area with caution.

U. S. Coast Guard East Report:

- St. Lucie River North Fork day beacon 31 is damaged and missing.
- Intracoastal Peck Lake day beacon 18 (south of St. Lucie Inlet) is damaged.
- Cape Canaveral Space launch operations are ongoing and hazardous to boaters during launch. Check launch schedule when boating through this area. You can call the US Space Force launch information hotline at: 1-800-470-7232.
- The FPL St. Lucie power plant breakwater lighted buoy G is damaged.
- The USCG is referring a case to the Justice Department for possible criminal charges after a collision between a sailing vessel and an uninspected barge/tow vessel that resulted in the deaths of three minors and injured two others. The accident happened near Hibiscus Island in Miami.
- Biscayne Bay light 69 is destroyed.
